#### **EXPLANATORY STATEMENT UNDER SECTION 102(1) OF THE COMPANIES ACT, 2013:**

Item No. 4:To consider the proposed amendments to the Club Bye-laws (as per Rule-34(d) and Articles of Association [Clauses No. 17(b), 17d) and 17 (f)]:-

#### Rule 34.(b) amendment as follows:-

- (v) To adopt amendment proposal as proposed under Rule 34(g)
- (vi) To discuss any other matter with the permission of the chair.

#### Rule 34.(d) amendment as follows:-

- (i) Any proposal for amendment of the Club Bye-law & Rules shall be sent to the Honorary Secretary in writing signed by at least ten valid Members by 30<sup>th</sup> July.
- (ii) The Honorary Secretary shall place the amendment proposal before the Legal Committee formed by the Managing Committee for their opinion.
- (iii) The legal opinion shall be placed before the Managing Committee at least 15 days prior to issue of notice for Annual General Body Meeting.
- (iv) Proposal for amendment of basic structure of the Bye-laws enshrined under Rule 1 to 17 (one to seventeen) shall be sent to the Honorary Secretary in writing signed by at least one tenth of valid members by 30<sup>th</sup> July.
- (v) The amendment proposal approved by the Managing Committee shall be circulated to all Members with the notice for Annual General Body Meeting inviting suggestion to be sent to Honorary Secretary within 15 days notice.

Item No. 5: To consider proposed Amendment of Clause-D (iv) of Rule-4 of Club Bye-law and Articles of Association [Clause No. 4 Group-A- (f)- Member's Children]:-

Clause-D(IV) of Rule-4 of Club Bye-law is stating that Children of Corporate Members shall not be eligible for induction as member of the Club on payment of induction fees at a concessional rate, provided they fulfill all other criteria applicable for membership.

I propose that Children of Corporate member where the nominees of the Corporate Members remain uninterrupted nominee for twenty of more years, children of such nominee shall be eligible for induction as member of the Club on payment of induction fees at a concessional rate, provided they fulfill all other criteria applicable for membership.

#### **Explanation:-**

Our Club has given Corporate Membership to Corporate Entities, Partnership Firms and sole Proprietorship Firms in past to collect more induction fees. Even there are instances where a person had applied for individual membership, but he was inducted as member under corporate member category. Therefore, I am of the opinion that such members should not be deprived of the benefit of inducting his/her children as member of the Club at concessional amount.

Hence, the following resolution should be passed in the forthcoming Annual General Meeting for amendment in Clause-D(IV) of Rule-4 of Club Bye-law.

"RESOLVED THAT Children of Corporate Members where the nominees of the Corporate Members remained uninterrupted nominee for twenty or more years, are eligible for induction as member of the Club at a concessional rate".

Item No. 6: To consider proposed Amendment to Rule 27 and 28 of Club Bye-Laws:-Following amendment proposals be made to Rule 27 of the Club Bye-laws:-

- 1. That, in absence of an Appointment and retirement policy of the Club, high time it is required for present management to draw such policies with retirement age and grounds for extension and/or reappointment of any employee which needs to be discussed for a fair & just decision in the AGM.(Rule-27)
- 2. That, decision in AGM on 22.09.19 was taken that if an employee of the Club is dismissed from service citing valid reasons, then he/she cannot be reappointed and therefore the present management is requested to place list of such dismissed and reappointed employees in past 3 years so as to take suitable decisions in the AGM.(Ref: clause-of of Rule-27)
- 3. That, the job extension of any employee after retirement should not be more than SIX MONTHS. Management has to recruit a suitable candidate to fill up the post.
- 4. That, One (1) CEO may be recruited to totally monitor the Club activities on day to day basis.
- 5. That, periodically (Every Six months) all employees should go through Job Orientation by a Professional Consultant.
- 6. That the report of the Consultant will help to assess the efficiency & credibility of employees.

Following amendment proposals be made to Rule 28 of the Club Bye-laws:-(Ref: Clause-m of Rule-28 in future wherein no provision for punishment).

- 1. That, any member or spouse found involved in business of profit with the Club for supply of goods and services directly or indirectly, he or she shall be terminated from membership of the Club and the Secretary and Treasurer of the corresponding period shall not be eligible to contest or hold any post whatsoever
- 2. That, if any business activity of a vendor/member or spouse for supplying goods or services at a later stage found that vendor has made extra profit as compared to the next best alternative source, the Secretary and Treasurer of the Treasurer of the corresponding period shall not be eligible to contest or hold any post whatsoever
- 3. That, if Club is required to avail the product and services urgently from members in such business and there being no transparent provision to meet such requirements, Managing Committee is requested to examine such purchases of past 3 years and device a clear and transparent policy for discussion and final decision in the matter with rules and punishment, if one is found guilty.
- 4. That, induction of full membership for next 3(three) years up to 2025-26, may be considered only on vacancy available during the same year.(Ref:Rule-28)

Item No. 7: To consider proposed Amendment to Rule 34 (c) of Club Bye-Laws and Articles of Association Clause No. 17 (c):-

#### (To add clause-C of Rule-34)

"That, any office bearer or member of the management committee or tax representative or statutory auditor of the Club, proved on records of being directly or indirectly responsible for dereliction in duties or non compliance with the accepted accounting standards for the post or profession held and caused financial loss to the Club in the matter of filing of Income Tax returns, payments of GST, provisions of Companies Act,2015, ESI and labour laws and rules and notifications framed there under, inter alia violation of provisions of all statues and Acts applicable to the Club, shall be liable to make good of financial loss with interest.

That for this purpose an enquiry shall be conducted by the management based on prima facie material on record to establish and determine willful dereliction of duty of any office bearer of the Club

or member of the Management Committee or tax representative or statutory auditor of the club and no enquiry shall last more than 30 days. That the members of the enquiry committee shall be drawn from club members who are adequately professionally qualified to enquire into the matter and who are not members of the management committee."

#### **Explanation: -**

A case has come to light about issue of tax demand by the income Tax Office based on scrutiny of our Tax Return for 2018-19 Asst. Year. Due to non response and non appearance before the Assessing Officer a best judgement assessment order was passed raising a demand of Rs. 5,10,660 plus interest and penalty of another Rs.5,21,000 approx. As a result instead of getting a refund the IT department adjusted a demand of Rs.10,31,320 against our TDS amount. Clearly it was a case of a failure of the concerned office bearer in charge of income tax matters at that time apart from the tax representative who rendered wrong advice and agreed with the capitalization of monthly charges.

Item No. 8: To consider proposed amendment in Clause –C of Group A of Rule 4 (Full Member) and Rule 5( Life Member) of Club Bye-Law:-

#### Induction/Admission fee:

The appropriate amendment in the Club Rules may be passed to incorporate the following clause:

"That the club shall not admit any individual as a member of the club unless he pays a sum of Rs.5,00,000 plus GST as induction/admission fee."

#### **Explanation:**

It is observed that we have a very low induction fee of Rs.1,80,000 for private individuals compared to our sister club i.e., Bhubaneswar Club which charges more than Rs.8,00,000 (excluding GST) towards admission. Unless we increase our admission fee our public standing and prestige suffers a hit since people will immediately tend to downrank us vis a vis Bhubaneswar Club. Hence, the proposed amendment.

Item No. 9: To consider proposed amendment/addition to Rule 17 (Guests) of Club Bye-laws and Articles of Association- Clause No.8 (Guest) regarding use of club facilities by outstation guests:-

#### Use of club facilities by outstation quests:

Proposed addition of this rule/amendment to the existing club rules governing guest entry.

"No local resident of Cuttack Municipal limits can be taken as a guest by any member. Every outstation guest has to submit complete postal address to establish his genuine normal place of residence. It is further provided that no member can entertain more than five guests on a particular day.

The management reserves the right to send letters to such address by courier/speedpost/registered post to verify the authenticity of the address and in case of non delivery due to fictitious address appropriate disciplinary action can be taken against the member for improper act. "

#### **Explanation:-**

It is observed that many members are taking local residents of Cuttack as guests and entering their address as "Bhubaneswar". To stop this unhealthy practice it is necessary to ensure that only genuine outstation guests are entertained by him. Secondly, it is seen that many times the restaurant gets crowded by huge number of guests signed in by members. Hence, it is proposed to impose a limit.

Item No. 10: To consider proposed amendment to Rule 23 of Club Bye-laws regarding eligibility of any Member to contest for election as member of Managing Committee:-

#### Criminal proceedings against any member or member of the Management Committee:

"If any managing committee member is in judicial or police custody of the police for more than 24 hours then he shall lose his post for the rest of the term of the committee. He shall not be eligible to contest for elections for the next 2 years.

If any member of the Club is booked on any criminal offence of a serious nature involving minimum punishment by a jail term of not less than 3 years then he shall be debarred from his rights as a member even when he is on bail till any court of law exonerated him,"

#### **Explanation:**

In 2022 a managing committee member was arrested for fraud and embezzlement of government funds in a health department scam and was in jail for several months. This was a very prominent news in several local newspapers and TV channels. Yet he continued as a managing committee member of the club since there is no provision to suspend him after arrest. This lowers the prestige of the club in the eyes of the public since such member should not hold any post nor be permitted to use the facilities even when he gets bail unless a court exonerates him.

Item No. 11: To consider proposed amendment/addition to Rule 24 of Club Bye-laws and Articles of Association, Clause No. 15:- All managing Committee members to be treated as Directors

#### The following rule may be inserted in the Club Rules:

"All fourteen members of the managing committee duly elected by the members in the AGM shall be treated as "Directors" of the club as per the Companies Act,2013 and the RoC shall be duly informed about their names and addresses after the elections are over."

#### **Explanation:**

At present only three members of the MC are treated as Directors and the respective Form is filed with the RoC for them only. It is a fact that all fourteen are part of the Managing Committee who manage the affairs of the Club and hence are legally responsible under the Companies Act,2013 for governance and proper administration of the Club which is a registered Company. Each one has specific role as per our Rules and in case of non compliance is liable to the Company under the Companies Act,2013. In fact, non furnishing of their names and DIN number is a violation under the Companies Act,2013 and the Club is liable to face proceedings by the RoC for this serious lapse.

Item No. 12: To consider proposed amendment/addition to Group- C, Rule 13 (c) of Club Byelaws and Article of Association – Clause No. 4 (Group C: Corporate Member):-

- 1. The owners and original director of the firms and companies may please be allowed to contest elections and eligibility at par like full members.
- 2. The son/daughter of corporate member nominees may be considered at par as children like regular members of club for getting new membership at a reasonable rate.

## ELIGIBILITY CRITERIA & RULES FOR CONTESTORS AS MANAGING COMMITTEE MEMBERS FOR THE PERIOD 2023-2024

- 1. As per Rule-34 of Cuttack Club Rules and Clause-17 of the Articles of Association, the Annual General Body Meeting of the Cuttack Club for the Year 2022-2023 will be held on 24.09.2023 (Sunday i.e., the normal working day of the Club) at 10.00 A.M in the Club Centenary Hall.
- 2. As per Rule-21(a) and Rule-22(1) of Cuttack Club Rules and Clause-14 and Clause-17(a) of the Articles of Association, the Managing Committee has decided to hold Cuttack Club Election for the Year 2023-2024 which will be through E-voting on 23.09.2023, Saturday (from 09.00 A.M. to 05.00 P.M.) and Physical Voting by Ballot held on 24.09.2023 (Sunday), the date on which the AGM is fixed, from 12.00 Noon to 3.00 P.M in the Club Centenary Hall
- 3. As per Rule-22(iii), Managing Committee has nominated the "Club Election Committee" with Dr.Santosh Kumar Moda,F/00111, as Chief Election Officer, Mr.BinodDash,F/00039 and Mr.Dillip Kumar Patnaik,F/00335 as Election Officers to conduct the Club Election for the Year 2023-2024.
- 4. As per Rule-34(b)(iv), Nomination for the post of President, Vice-President, Honorary Secretary, Joint Secretary, Treasurer and Nine (9) Managing Committee Members should be filed **on or before 10.00 P.M of 06.09.2023(Wednesday).**
- 5. As per Rule-22(ix)(a), Nomination Forms (as per Annexure-III & Page-24 of Cuttack Club Rules) will be available during normal Office hours in the Club Office on payment of Rs.200/- for each Form from 10.00 A.M of 03.09.2023(Sunday) to 06.09.2023 (i.e. Wednesday till 10.00 P.M.)
  - N.B: (a) Any person who is interested to contest for any post of the Managing Committee of the Company or become Director, then he/she must not be disqualified under Section 164 (1) and (2) of the Companies Act, 2013 and shall also furnish declaration for the same with Nomination Form in **Annexure-5**, format available at Club office during working hours in between 3<sup>rd</sup> September, 2023 & 6<sup>th</sup> September, 2023 till 10.00 P.M. It is further informed that any Member who is elected as Managing Committee Member, and who will be appointed as Director has to obtain DIN and furnish consent in **Form DIR-2** (format available at Club office during working hours) under Section 152(5) of the Companies Act, 2013 for being appointed as Director before taking Charge as Office Bearer/ Managing Committee Member of the Company.

Section 152 (4) of the Companies Act, 2013 says - Every person proposed to be appointed as a director by the company in general meeting or otherwise, shall furnish his Director Identification Number and a declaration that he is not disqualified to become a director under this Act.

- N.B: (a) As per Rule-22(ix)(a), No Member can file his Nomination for more than One Post in the Managing Committee and similarly, No Member, residing beyond Cuttack District can file his Nomination for any post in the Managing Committee.
- N.B: (b) As per Rule-23(e), Nominee of the **Corporate Member cannot contest for any Post** of the Managing Committee (as amended in the AGM-2017 dated 24.09.2017 & ROC).
- N.B: (c) As per Rule-23(g), if any Member has been elected for any post (Member of Managing Committee or Office Bearer) for two years in succession, she/he cannot stand for the same post for the third successive Year.
- N.B: (d) As per Rule-23(h), No Member shall be eligible for election for more than 4(four) times to any post of the Managing Committee or Office Bearer during her/his whole period of Membership of the Club(as amended in the AGM-2017 dated 24.09.2017 & ROC).
- N.B: (e) As per Rule-23(c), No Member of the Club shall be eligible to contest for the Office of the Vice-President, Honorary Secretary, Joint Secretary and Treasurer unless she/he has been twice elected as Member of the Managing Committee.
- *N.B:* (f) Name must be only name and prefixes or suffixes or nick names should not be added in the Nomination Paper and Ballot Paper.
- 6. As per Rule-22(ix)(b), the following Security Deposits shall be deposited by the Candidate along with the Nomination Paper for Election:
  - (a) There shall be no Security Deposit for the Post of President.
  - (b) For Vice-President, Honorary Secretary, Joint Secretary and Treasurer---Rs.5,000/-
  - (c) For Managing Committee Member---Rs.3,000/-
- 7. The names of the proposed Candidates together with the names of the Proposer and Seconder will be displayed on the Notice Board on **06.09.2023(Wednesday)**
- 8. **Scrutiny of Nominations** will be made by the Club Election Committee on **08.09.2023(Friday).** A provisional list of valid Nominations will be displayed on the Notice Board on the same day after Scrutiny.
- 9. The last date of receipt of objection from any candidate relating to the proposed rejection of nomination, if any, will be on 10.09.2023(Sunday) before 10.00 P.M.
- 10. As per Rule-22(xiv), the candidate may appeal to the Appellate Committee against her/his rejection of nomination on **11.09.2023(Monday) before 10.00 P.M.**
- 11. Final list of valid Candidates after consideration of objection (if any) by the Appellate Committee and Club Election Committee will be displayed on the Notice Board by 10.00 P.M on 14.09.2023(Thursday).
- 12. As per Rule-22(xvii), the last date for withdrawal of nomination by any candidate from the Election process will be no 15.09.2023(Friday) before 10.00 P.M. The final list will be published after 10.30 PM on the same day.
- 13. As per Rule-25(c), a Member who has outstanding Club Dues against her/him shall not be eligible to propose/second names of Candidates for the Election. She/he shall not be eligible to contest for any post in the Election nor cast her/his vote in the Election.

- 14. (a) As per Rule-22(xii) and Rule-25(c), the "CUT OFF" date for payment of outstanding Club Dues (as on 31.07.2023) by the Members to become eligible to vote at the Club Election will be seven days before the date of Club Election i.e., 15.09.2023(Friday).
  - (b) As per Rule-22(ix)(d), Members desirous of contesting Election for any post should clear their all outstanding Club Dues (including monthly Subscription, Kitchen, Bar, Gym Games etc.) till 31.08.2023 (as amended in the AGM-2017 dated 24.09.2017), before filing of Nomination Paper. The outstanding Club Dues of the Proposer and Seconder must be cleared till 31.07.2023.
- 15. Members are requested to collect their "No Dues Certificate" from the Club Office during Office hours between 03.09.2023 and 15.09.2023.
- 16. Members are required to produce their "Valid Identity Card" along with "No Dues Certificate" for voting in the Club Election on 24.09.2023(Sunday).
- 17. (a) As per Rule-22(vi), Voting shall be by Secret Ballot and voters will indicate their preference (votes) with the "MARKER" provided by the Club Management in each booth. Votes marked with Pencil, Pen or any other way will be treated as "INVALID" and hence "REJECTED".

- 21. As per Rule-10, the Honorary Members are not eligible to propose, second names of the candidates or to contest neither for any post nor to vote at the Club Election.
- 22. As per Clause-(q) of Rule-14, the Probationary Members are not eligible to vote at the Club Election.
- 23. As per Clause(j) of Rule-23, each and every contestants will be allowed 4-5 minutes to speak about their vision (What-I-Stand-For) for the Club in between 18.09.2023 and 22.09.2023 (as amended in the AGM-2019 dated 22.09.2019 & ROC).
